Shoplifting and Dishonest Employee Average Case Values Increased in 2020, According to Jack L. Hayes International's 33<sup>rd</sup> Annual Retail Theft Survey!

**WESLEY CHAPEL, FL** - Jack L. Hayes International, Inc. released today the results of their 33<sup>rd</sup> Annual Retail Theft Survey which reports on over 184,000 shoplifters and dishonest employee apprehensions in 2020 by just 22 large retailers, who recovered over \$81 million from these thieves.

"While temporary store closures due to the Covid-19 Pandemic resulted in fewer thieves being caught stealing in 2020, the average shoplifting case value increased 13.0% and the average dishonest employee case value increased 3.8% over 2019," said Mark R. Doyle, President of Jack L. Hayes International, Inc. Mr. Doyle added, "As expected, the Covid-19 Pandemic clearly affected apprehensions and recovery dollars in 2020, with shoplifting apprehensions and recovery dollars down 43.8% and 36.5% respectively; and dishonest employee apprehensions and recovery dollars down 20.3% and 17.2% respectively. However, those participant retailers designated as 'essential', saw overall apprehensions rise 7.9% and dollar recoveries increase 9.1% during 2020."

COVID-19 PANDEMIC CLEARLY AFFECTED 2020
APPREHENSIONS AND RECOVERY DOLLARS!

While temporary store closures due to the Covid-19 Pandemic resulted in fewer thieves being caught stealing in 2020, the average shoplifting and dishonest employee case values increased.

# HIGHLIGHTS FROM JACK L. HAYES INTERNATIONAL'S 33rd ANNUAL RETAIL THEFT SURVEY

## **TOTAL RETAIL THEFT**

- Survey participants apprehended a total of 184,621 dishonest individuals (shoplifters and employees) in 2020, a decrease of 41.3% from the prior year. Dollars recovered from those apprehended thieves decreased 30.0% to \$81.3 million in 2020. ("Essential" Retailers' stats up 7.9% and 9.1%.)
- For every \$1.00 recovered by our surveyed companies, \$33.15 was lost to retail theft. Therefore, <u>only 2.9%</u> of total retail theft losses resulted in a recovery.

## **SHOPLIFTING**

- **Apprehensions:** Survey participants apprehended 158,158 shoplifters in 2020, a decrease of 43.8% from the prior year. ("Essential" Retailers reported apprehensions up 8.6%)
- **Recoveries:** Dollars recovered from shoplifting apprehensions totaled over \$49.0 million in 2020, down 36.5% from 2019. ("Essential" Retailers reported recovery dollars up 15.3%)
- **Recoveries (no apprehension):** Dollars recovered from shoplifters where no apprehension was made (over \$87 million) decreased 42.8% in 2020.
- **Case Value:** The average shoplifting case value in 2020 was \$310.11, an increase of 13.0% from 2019 (\$274.40).

## **EMPLOYEE THEFT**

- **Apprehensions:** Survey participants apprehended 26,463 dishonest employees in 2020, down 20.3% from 2019. ("Essential" Retailers reported apprehensions up 2.7%)
- **Recoveries:** Dollars recovered from dishonest employee apprehensions totaled over \$32 million in 2020, down 17.2% from 2019. ("Essential" Retailers reported recovery dollars up 0.1%)
- Case Value: The average dishonest employee case value in 2020 was \$1,219.61, an increase of 3.8% from 2019's average case value (\$1,174.61).

## **Shrink Trend:**

09 of the 22 retailers (41.0%) had an increase in company shrink.

12 of the 22 retailers (54.5%) had a decrease in company shrink.

01 of the 22 retailers (04.5%) had no change in company shrink.

## **Shoplifting Apprehensions:**

04 of 22 retailers (18.2%) had an increase in shoplifter apprehensions.

14 of 22 retailers (63.6%) had a decrease in shoplifter apprehensions.

04 of 22 retailers (18.20%) had no change in shoplifter apprehensions.

## **Shoplifting Recoveries:**

04 of 22 retailers (18.2%) had an increase in shoplifter recovery dollars.

14 of 22 retailers (63.6%) had a decrease in shoplifter recovery dollars.

04 of 22 retailers (18.2%) had no change in shoplifter recovery dollars.

## **Shoplifting Recoveries Without an Apprehension:**

08 of 15 retailers reporting (53.3%) had an increase in shoplifting recovery dollars without an apprehension.

07 of 15 retailers reporting (46.7%) had a decrease in shoplifting recovery dollars without an apprehension.

00 of 15 retailers reporting (00.0%) had no change in shoplifting recovery dollars without an apprehension.

## **Dishonest Employee Apprehensions:**

03 of 22 retailers (13.6%) had an increase in employee theft apprehensions.

19 of 22 retailers (86.4%) had a decrease in employee theft apprehensions.

00 of 22 retailers (00.0%) had no change in employee theft apprehensions.

## **Dishonest Employee Recoveries:**

04 of 22 retailers (18.2%) had an increase in employee theft recovery dollars.

18 of 22 retailers (81.8%) had a decrease in employee theft recovery dollars.

00 of 22 retailers (00.0%) had no change in employee theft recovery dollars.

Based upon our survey results, for every \$1.00 recovered, \$33.15 is lost to retail theft. Therefore, **only 2.9 percent** of total retail theft losses result in a recovery.

## **Support/Calculation for the Above Statement:**

- Annual retail sales of the participating companies were \$507,977,933,327.
- According to the 2020 National Retail Security Survey, the average shrinkage is 1.62% of sales (at retail).
- Shrinkage allowance for paper/systems/operational errors was assigned a **conservative** 30% dollar figure.

**Thoughts Behind The Numbers** 

<u>SHOPLIFTING</u>: We asked our survey participants why their Shoplifting apprehensions and recovery dollars increased or decreased in 2020; they contributed the following:

## Increased:

- ORC (Organized Retail Crime) continues to be a primary factor
- Less stores to choose/steal from
- Saw significant increase in "theft for need"
- · Legislation increasing felony thresholds embolden thieves
- More 'hit n run'/fleeing shoplifters

### Decreased:

- Store closures resulted in less shoppers
- Transition to deterrence/recovery during pandemic
- Closing of fitting rooms for extended periods of time
- Focused on better customer service
- Less LP/AP staff due to restructuring or transition

<u>EMPLOYEE THEFT</u>: We asked our survey participants why their Dishonest Employee apprehensions and recovery dollars increased or decreased in 2020; they contributed the following:

#### Increased:

- More focus/attention towards associate theft
- Improved technology/analytic tools resulted in more DE cases
- Fewer associates in store created more opportunities for dishonest employees
- Increase in loyalty card fraud
- Increase in discount abuse cases

#### Decreased:

- Store closures and furloughed associates
- · Less focus on apprehensions and more focus on pandemic issues
- Better prevention with additional technology at POS
- Reduced travel by LP/AP staff
- Decrease in LP/AP staff due to restructuring or transition
